IBOARD Rigid PIR Insulation Board - Concealed Brick Cavity, Soffit Applications & Frame Wall

## **Insulation Material:**

The concealed cavity / soffit insulation / frame wall shall be IBOARD \_\_\_\_ mm thick, with a thermal value of R\_\_\_\_, comprising a closed-cell CFC/HCFC-free, zero ozone depletion potential (ODP), non-corrosive, zero formaldehyde content, rigid thermoset polyisocyanurate foam core with two reflective gas-tight aluminium foil facings, tested in accordance with AS/NZ standards to comply with the BCA/NCC and manufactured by Blue Chip Group Pty Ltd (Ph: 1300 945 123).
